

RETURN CONDITIONS

General:

Resch GmbH & Co. KG takes over the fast and flexible collection of used industrial packaging, which includes intermediate bulk containers (IBC), steel drums and plastic drums. In a sustainable process the industrial packaging is reconditioned in an environmentally friendly manner and recycled. Through the use of original or approved components, these components, they continue to have full product safety.

The collection is carried out by Resch GmbH & Co. KG according to the agreed conditions, provided that the return conditions are complied with by the sender.

By placing the order, the customer warrants that he will not use Resch GmbH & Co. KG conditions of return and that in case of non-observance he will be responsible for the costs incurred in the event of non-compliance. The sender himself is liable for any kind of damage caused during the improper or inappropriate handling of the industrial packaging and its contents. industrial packaging and its contents. The national and international laws and regulations must be observed and complied with at all times.

The consignor undertakes to ensure that each industrial packaging reported for collection by Resch GmbH & Co. KG, complies with the following criteria. If one of these conditions is not met, Resch GmbH & Co. KG shall have the right refuse to accept the industrial packaging or return it at the expense of the sender. return it at the expense of the sender.

The number of packagings specified in the order must correspond to the number of industrial packagings ready for collection must correspond

Industrial packaging must not be damaged in such a way that it can no longer be reconditioned. I.e. especially for IBCs: inner containers, steel cages, pallets or other functional parts must not show any structural damage and no severe oxidation.

The industrial packaging must be emptied of residues according to the state of the art, i.e., drip-free, spatula-clean and/or free-flowing. All industrial packaging must be be free of adhering residues on the outside. Transport in accordance with the Hazardous Goods Law as "empty packaging" under "exempted quantities according to chap. 1.1.3.6, ADR" is otherwise excluded.

Outlet fittings and/or other closure systems must be in working order. be present. For transport purposes, each empty package must be as closed and as tight as a filled industrial package.



The last product must be clearly identifiable. Label plates, filling product stickers and hazardous material instructions must be legible. If not applicable, uncleaned, empty packaging must be marked with the same inscriptions (UN no. and dangerous goods regulations with the same inscriptions (UN No. and name of the dangerous and name of the dangerous goods) and hazard labels as for filled packages. The transport documents must comply with the regulations.

Resch GmbH & Co. KG reserves the right to refuse acceptance of used industrial of used industrial packaging that poses a potential risk to health or the health or the environment (e.g. toxic, highly flammable, toxic to hereditary toxic, highly flammable, mutagenic, carcinogenic and/or strong-smelling contents), to be rejected. Such filling products will only be taken back if they are neutralized and marked with the label "NEUTRALIZED".

The safety data sheet of the filling product must be made available on request. be provided.

Industrial packaging that does not meet the above-mentioned requirements or that cannot be or which cannot be reconditioned, will be returned to us against reimbursement of the transport, residual transport, residual material, disposal, treatment and recycling costs to be agreed in advance. material recycling costs. Packaging which has been packaging which has been handed in with false information shall be returned to the returned to the customer at the customer's expense and risk.
